



Goldthorn Park Primary School SEN Information Report for 2023 - 2024

Welcome to our SEN Information Report which is part of the Wolverhampton Local Offer for Learners with Special Educational Needs (SEN). All schools are supported to be as inclusive as possible, with the needs of pupils with Special Educational Needs and Disabilities being met in a mainstream setting wherever possible.

The four broad 'areas of need' are Communication and Interaction, Cognition and Learning, Social, Emotional and Mental Health, Sensory and Physical Needs.

At Goldthorn Park Primary School, we embrace the fact that every child is different, therefore, the educational needs of every child is different; this is certainly the case for children with Special Educational Needs.

1) How does the School know if children need extra help and what should I do if I think my child may have special educational needs?

At different times in their school life, a child or young person may have a special educational need. The Code of Practice 2014 defines SEN as follows:

"A child or young person has SEN if they have a learning difficulty or a disability which calls for special education provision to be made for him or her. A child of compulsory school age or a young person has a learning difficulty if he or she:

- a) has a significantly greater difficulty in learning than the majority of others the same age, or*
- b) has a disability which prevents or hinders him or her from making use of facilities of a kind generally provided for others of the same age in mainstream schools or mainstream post-16s institutions."*

Where pupils' progress is significantly below age related expectations, despite high quality teaching targeted at specific areas of difficulty, provision of SEN Support may need to be made.



Our Graduated Approach

Class Teachers identify if pupils require further support with their learning. At this point, the **Special Educational Needs and Disabilities Co-ordinator (SENDCo)** specifically identifies areas of need and pupils are given appropriate support.

If the teacher feels that more support is required then pupils will be moved to WAVE 2.

At WAVE 2 this means that they will have an **Individual Learning Support Plan (ILSP)**. Pupils will have interventions throughout the week working either 1:1 or in small groups to support their targets. These targets will be shared with Parents at Review Meetings and the views of the child will be included.

If further concerns are raised by Class Teachers or Parents, then the SENDCo will complete referral forms to our Specialist Teachers in order to offer specialist advice. Specialist Teachers can also offer support and advice to Teaching Staff.

Pupils who have more complex learning needs may require comprehensive provision and assessment. These pupils are WAVE 3 and maybe supported by an Education Health and Care Plan - Needs Assessment (EHC - NA). This is a personalised plan and provides key targets and actions for all professionals involved in the pupil's education.

If you have any concerns regarding your child's progress or well-being, please speak to either your child's Class Teacher or **Miss H Morgan - SENDCO** to discuss your concerns.

2) How will the School support my child?

The Class Teacher

Responsible for...

- Checking on the progress of your child and identifying, planning and delivering any additional help your child may need (this could be targeted work or additional support) and informing the Special Education Needs and Disabilities Co-ordinator (SENDCo)
- Personalised teaching and learning for your child as identified on the child's Individual Provision Map.
- Ensuring that the school's SEND Policy is followed in their classroom and for all the pupils they teach with any SEND.

The SENDCo: Miss H Morgan

Responsible for... Special Educational Needs



- Providing professional guidance to colleagues and working closely with staff, Parents and other agencies.
- Writing the SEN Information Report which must be published on our school website and updated annually.
- Overseeing the day-to-day operation of the school's SEND policy.
- Co-ordinating provision for children with SEND.
- Advising on a graduated approach to provide SEN Support.
- Advising on the deployment of the school's delegated budget and other resources to meet pupils' needs effectively.
- Liaising with Parents of pupils with SEND.
- Liaising with EYFS providers, other schools, Educational Psychologist, Health and Social Care Professionals and Independent or Voluntary Bodies, Local Authority.
- Managing the transition process - between the varying levels of SEN support, from one year group to the next and also any change of school.
- Ensuring school keeps the records of pupils with SEND up-to-date.
- Working with Heads of School and School Governors with regards to reasonable adjustments and access arrangements.

Headteacher: Mrs R Purshouse

Responsible for...

- The day-to-day management of all aspects of the school; this includes the support for children with SEND.
- The Headteacher will give responsibility to the SENDCo and Class Teachers, but they are still responsible for ensuring that your child's needs are met.
- The Headteacher must make sure that the Governing Body is kept up-to-date about issues relating to SEND.

The Governors

Link SEND Governor - Mrs J Ahir

Responsible for...

- Making sure that the necessary support is given for any child with SEND who attends our school.
- To support and challenge the Headteacher and SENDCo with regards to SEND within our school.

3) How will the curriculum be differentiated to match to my child's needs?

If a learner is identified as having SEND need(s), the school will provide support that is **additional to** or **different from**, the differentiated approaches and learning arrangements



normally provided as part of high quality, individualised teaching. This support is set out in the child's Individual Provision Map, which documents the support your child will receive.

When providing support that is "additional to" or "different from" we engage in a four-stage process:



Assess - this involves taking into consideration all the information from discussions with Parent(s)/Carer(s), the child, the Class Teacher and assessments.

Plan - this stage identifies the barriers for learning, intended outcomes, and details what additional support will be provided to help overcome the barriers. Decisions will be recorded on the Provision Map and will form the basis for review meetings.

Do - providing the support - extra assistance for learning - as set out in the plan.

Review - measuring the impact of support provided, and consider whether changes to that support need to be made. All of those involved - Learner, Parent(s)/Carer(s), Teacher, SENDCO and outside Agencies contribute to this review. This stage then informs the next cycle.

Goldthorn Park Primary adheres to the following inclusive principles:

Staff value pupils of different abilities and support inclusion. Within our school, staff and pupils will be constantly involved in the best ways to support all pupils' needs within our school. There is flexibility in approach in order to find the best provision for each child. Within each class, teaching and learning styles and organisation will be flexible to ensure effective learning. Grouping to support children identified with additional needs, will be part of this process.

4a) How will both you and I know how my child is doing and how will you help me to support my child's learning?

There will be an opportunity for Parent(s)/Carer(s) to meet with their child's Class Teacher and SENDCo to review the short term targets and to discuss the progress your child has made. We also encourage an "open door" approach whereby Teachers/SENDCo are accessible at the end of the day.

- Your child's progress will be continually monitored by his/her Class Teacher.
- Progress will be reviewed formally and tracked by the Headteacher and SENDCo every term in Reading, Writing and Maths. Through Parent/Carer Consultations and end of year reports, Teachers make clear the attainment against **Age Related Expectations (AREs)** and the number of steps progress made by your child(ren).
- At the end of Key Stage 2 (Year 6), all children are required to be formally assessed. This is something the Government requires all schools to do and the results are published nationally.
- Where necessary, children will have an **Individual Learning Support Plan (ILSP)** based on targets set by school/outside Agencies specific to their needs with the intention of accelerating learning and to close the gap. Progress against these targets will be reviewed regularly, evidence of judgments assessed and a future plan made.
- The progress of children with an **Educational, Health and Care Plan (EHCP)** will be formally reviewed at an Annual Review with all adults involved with the child's education.
- The Headteacher and SENDCo will monitor the progress made by SEND children in their classwork and any intervention that has been put into place.
- Regular book monitoring and lesson observations will be carried out by the SENDCo and other members of the Senior Leadership Team, to ensure that the needs of all children are met and all children have access to high, quality teaching.

Whole school newsletters are sent home sharing school news, community information, calendar dates, information about special events/celebrations in school. Also, extra information can be found on our school website including class news, photograph gallery, activities, homework and useful links. In addition to this, where necessary, we communicate via home/school link books e.g. reading journals/homework journals.

4b) What support will there be for my child's Social Emotional Mental Health?



We recognise some children have additional social, emotional and mental health needs that must be developed and nurtured. All classes follow a structured **Personal, Social, Health Education (PSHE)** curriculum to support this development. However, for those children who find aspects of this difficult we offer:

- Lunchtime and playtime support
- Buddy system
- Individualised programmes of work
- Access to external agencies and professionals and we follow their advice

The school benefits from a Behaviour for Learning Policy with clear rewards and sanctions. In respect of Anti-bullying, there is a policy in place that has been drawn up with staff and pupils and is accessible to Parents.

Any pupils with additional medical needs are well cared for at Goldthorn Park Primary School. All medical requirements are requested from Parent(s)/Carer(s) prior to admission (or as soon as possible after a place is allocation) and these are added to the school Medical Needs folder. Health Care Plans are drawn up in conjunction with our School Nurse Michelle Allen and Parent(s)/Carer(s). All medicines are kept in a medical cupboard accessible to appropriate members of Staff (See Medicines in School Policy).

There are various opportunities for all pupils to have a voice on decision making in our school. The school has a pro-active School Council that meets regularly. The Senior Leadership Team carry out pupil voice questionnaires. Prior to SEND review meetings, pupils have the opportunity to share their views.

5) What specialist services, expertise, training and support are available at or accessed by the School?

Once our school has identified the needs of SEND pupils, the SENDCo and Headteacher decide what resources/training and support is needed.

School Provision:

- Wide range of Literacy and Maths small group interventions delivered by Teaching Assistants and designated Teachers
- Phonic intervention groups
- Additional reading support
- Speech and Language support using Elklan principles.
- Additional 1-1 learning sessions with the SENDCo
- Pastoral Support

Local Authority provision available:

- Outreach support from Tettenhall Wood School/Westcroft School/Penn Fields School/Penn Hall School



- Educational Psychology Service
- Specialist Teacher Service
- Special Needs Early Years Service
- Sensory Inclusion Team
- Strengthening Families HUB (Locality Team)

- Occupational Therapy
- Physiotherapy

6) What training have the Staff supporting children and young people with SEND had or are having?

The appropriate Staff have training and development opportunities in the following:

- The SENDCo is working towards the National SENDCo Award for SEND Co-ordination and keeps updated on SEND through attendance at regular Local Authority SEND Network meetings, Local Area SEND Network meetings. Relevant SEND information/training is shared/delivered to all Staff during Staff/Phase meetings/INSET days.
- At Goldthorn Park we have a culture of sharing good practise and expertise; this enables us to ensure our Staff have as much knowledge as possible within the field of supporting children with SEND.
- All new members of Staff receive in-house training with regards to the SEND Policy and Safeguarding.
- All Staff - Level one Autism Awareness Training - delivered by Tettenhall Wood Outreach/SNEYS
- Positive Handling
- Cool Kids & Cool Characters
- EAL (English as an Addition Language) training has taken place in Staff meetings/INSET days; supporting Staff in delivering teaching strategies for both new arrivals and more advanced second language learners.

7) How will my child be included in activities outside the classroom including school trips?

At Goldthorn Park Primary School we believe all learners are entitled to the same access to extra-curricular activities, and we are committed to making sure reasonable adjustments are made, to ensure participation for all. Please contact School if your child has any specific requirements for extra-curricular activities.

8) How accessible is the school environment?

- The school is on a single level with easy access and ramps.
- There is one disabled toilet and changing facilities.
- We ensure wherever possible that equipment used is accessible to all children regardless of their needs.
- For English as an Additional Language (EAL) children and Parents, several members of staff speak Punjabi/Hindi/Urdu
- Extra-curricular activities are accessible for children with SEND.
- The school has two outside learning areas (adventure playground and school field) and a separate Nursery and Early Years Outdoor Area.

9) How will the school prepare and support my child to join the school, transfer to a new setting or the next stage of education and life?

New pupils to Goldthorn Park Primary School

Foundation Stage Staff will arrange a home visit prior to pupils starting school. Concerns about particular needs will be brought to the attention of the SENDCo. Where necessary the SENDCo will arrange a further meeting with Parent(s)/Carer(s), previous setting, Health Visitor etc.

Children joining from other schools, their Class Teacher, will receive information from the previous school; if required the SENDCo will telephone previous school to discuss individual pupil's needs.

Preparing for next steps

Transition is a huge part of life for all Learners, whether that involves moving to a new class or moving to a new school. We recognise that transition is an important time for all children, but especially so for a child with SEND. Consequently, we work closely with Parent(s)/Carer(s), Pupils and Staff to ensure these transitions run as smoothly as possible.

Planning for transitions within the school will take place in the Summer term; arrangements for transition to Secondary School for pupil(s) with SEND will be planned according to individual need.



10) Provide examples of interventions, equipment, resources that School may allocate to match children's Special Educational Needs?

- Specific ICT programs for individual pupils/needs e.g. Reading Eggs/Purple Mash/TTRock Stars/MyMaths)
- Direct phonics programme
- Specific Speech and Language resources
- Elklan programme and resources
- Sensory resources/Sensory Room
- 1:1 teaching for reading, writing and maths

11) How is the decision made about what type and how much support my child/young person will receive?

The school budget includes money for supporting children with SEND.

The Headteacher and Inclusion Leader decides on the deployment of resources for Special Educational Needs and Disabilities, in consultation with the school Governors on the basis of needs in the school.

The Headteacher and the SENDCo discuss all the information they have about SEND in the school, including the children already receiving extra support, children needing extra support and the children who have been identified as not making as much progress as would be expected. From this information, they decide what resources/training and support is needed.

The school identifies the needs of SEND pupils on Individual Provision Maps. This identifies all support given within school and is reviewed regularly and changes made as needed, so that the needs of children are met, and resources are deployed as effectively as possible.

12) How are Parents involved in the school? How can I be involved?

At Goldthorn Park, we value the importance of building positive relationships with Parent(s)/Carer(s) and families within our school community. Members of staff are available every morning in School to record any messages from Parent(s)/Carer(s) and to pass these on to Class Teachers. Parent(s)/Carer(s) can also make appointments to meet with a member of staff at the end of the day. Parent(s)/Carer(s) can also make arrangements to meet with the SENDCo or a member of the Senior Leadership Team.
